HyperCube Session 4d

Melainah:

So in our last session, as Kuthumi was finishing up his transmission, I observed a second energetic block of energetics coming in that was separate from the holographic upgraded imprints that he had helped us set in play. And I watched this second thing coming in and I was trying to figure out, what is that? I understood immediately that it was from Andromeda as well, but I didn't know exactly what it was signifying.

Anyway, I couldn't stay with it very long because he was finishing up and it was my time for my segment, so I had to leave that to re-focus. But just for a really quick momentary glance I was aware of this massive energetic block coming in in my field. And as I looked at all of you within our Temple, sitting in our section, each one of you had one of these massive blocks of energetics, and that was coming into your field. So I had to leave that there. And when we finished the session, I went back in to look at what it was. And what we received was a massively upgraded block of Quantum Light geometries.

If you can see this graphic. Okay. And this particular graphic is, this geometric form is a hypercube. And I really like the graphic itself. But the hypercube; this kind of gives you a very basic beginning idea of the multiplicity of the geometries we're playing in. And do you see all those different cubes? And they continue to build and to build and to build. So, we absolutely are not limited by the cube.

I'm using this graphic because, to make the point that where we are is, and the geometries we're playing in are this and so much more. So this gives you a little bit more information about what else is occurring in your field as you are receiving all of these massive energetics and downloads. And this is occurring.

And you can watch a cube coming in, and it transformed from one dimension all the way to 12th dimension. And you can see the complexities of that, which is just; it is. Even the caption says it is mind-blowing, and it is. And I don't know if those of you who saw DiAna's graphic she posted in the last day or two; with a wonderful representation of the hypercube. And she posted that without knowing we were going to have this discussion today, so we're all right in sync.
