Announcements Open Discussion Infusion Sequences
Sunday, March 8, 2026

Joan: Hello everyone. It's wonderful to be with everyone today. I'm glad to see so many beautiful faces. So, Melainah, you want to say hello?

Melainah: Hello, everybody. Happy 2026.

Joan: Well, I only have one announcement that I'd like to make, and that's for the next two sessions.

The next meeting will be in two weeks on **March the 22nd** - and this is an important initiation. And then the following that - the next one will be on **April the 19th**.

So, if you want to put that on your calendar so that you have it, that'd be great.

Okay, Melainah, you had some things you wanted to say before we get started.

Melainah: I need to get my notes, because I don't remember everything. Let's see. A couple things. Because we are, of course we're just getting started with the series, and our scheduling won't be a set schedule as it has been in previous years.

So, for that reason, you know, try to get in the habit if you don't already or you don't receive notifications from your Facebook page that we have posted something, try to get in the habit of checking that Facebook page, the Ascending Masters page, at least once a week. That way, that's where we'll post first. If something changes in the schedule, or we're going to add another session or something that we feel like you need to know.

So, we've had kind of a three months quiet time, so you haven't heard much from us other than preparing for these initiations, these sequences of the initiations. So anyway, do get in the habit if you will, of checking that, because that's where it'll post first. And then Joan and Kimberly will send out an email for anything that needs a follow-up to that. So, kind of watch for that as well. And if we're gonna send an email and we know it ahead of time, we'll post that on the Facebook page too so you know to check. I know with me, I'm retired now, I'm not on my computer all the time anymore. So, Facebook, I do receive the notifications. And I don't know if all of you do, if you have Facebook on your phone. I receive them on my phone because I do have the app on my phone because I'm an administrator. I don't know whether all of you receive it or not on your phone. Can somebody tell me if you do, or no, or don't? You get them.

So, if you have the app, the Facebook app on your phone, then you would receive the notifications. Okay. But otherwise, if you don't, then you'll have to make a point of going onto Facebook and just see if we'd left any messages because again, this won't be a set schedule. Because of the fact where these frequencies that we're playing in, it depends on how quickly we're able to stabilize them before they're going to give us the next piece, okay. I think that makes sense. Yeah. All right. And yeah, I think those are the two things.

And the only other thing I like to say here at the beginning, for the few people who are not with us live today, and you're listening to this later - we're going to have, after Joan and I finish with whatever announcements we have, we'll go into our open discussion. But following that, we're going to go into some, a couple of segments about what's coming and things you will need to know. So do, you know, make sure if you are joining or, excuse me, listening to this later that you go toward the end of this conversation, and so you will hear what has been discussed about what's happening. Okay? And that's it.

Joan: Okay. And the other thing I would like to say about that is, like Melainah said, there's a lot of energy flowing. And because of that, we don't always pay attention to things. And so if, in regards to the emails, I'm making every effort to make sure that those things on the MailChimp are correct, and they are as far as I know.

It would be helpful if you would put the Ascending Masters or Illumination Series in your contact list, because otherwise sometimes even though it's through MailChimp, sometimes it'll go to a spam folder, it just doesn't get delivered. So, if you put that on your contact list that would help to make sure everybody is getting their e-mails. [Question about email addresses.] Kimberly, can you answer that. You take care of that.

Kimberly: Yeah, it goes to the email that you got and see what the - let me look here. I'll tell you real quick. Hold on. It came from Ascending Light Masters. Yeah, what you'll need to do is in that e-mail that just came out, it says from - and take that e-mail address and put it in the add to contacts. Just have to hover over it and say add to contacts.

Melainah: And the other thing I just thought about was that, on like this one, we sent the email the link for the zoom link on Thursday. So, we're going to try to send them on Thursday to give you one more day to locate it and to let us know.

Joan: Yeah, because a lot of times Melainah and I are not available on Sunday. So, if you aren't checking that till Sunday...

Melainah: ... odds are we won't see it most of the time, you know.

Joan: Because energetically, you know, we're preparing and getting ourselves centered. So, I don't even, you know, a lot of times on a Sunday morning, I don't even look at that.

Melainah: So, they should start going out on Thursdays going forward. Again, we'll give you an extra day to locate it when you know we're going to have a session upcoming. So start looking on Thursday for that email. And then let us know

Joan: And by Friday or Saturday, if you don't - Let us know. Yeah. Contact us because we want to make every effort to have everybody live that can come at our time. Because I think that's really important for the energetics for everybody. Okay.

This session will start off with an opening group discussion on what you've experienced or what you want to share with our group, and then Melainah wants to talk about our next infusion. And she's going to bring through some information from the Council. And then before we close, An Ra Ta will come forth and talk to us a little bit. And then we'll close our session.

So that's the itinerary for today. Okay, so let's just open it up for anybody. You'll have to unmute yourself - that would like to talk about what's been going on over this - since the winter solstice and these big initiations and energetics that we've been getting and participating in. We'd love to hear.

Melainah: Yeah, right, what have you been noticing, you know, any changes going on with you, anything you'd like to share, you know, the floor is yours. Don't all speak at once now. Okay, come on, don't be shy.

Open group discussion...

Joan: Yeah well, I think that's a common reaction. When that Zeal point opened, that was a big deal. And was said about it other than what it was. And so, it's one of those things, you know, Kuthumi used to say, that it's not about learning it so much as about experiencing it, when you experience it, then you know.

And that Zeal point is very instrumental. It's a part of the brain that opens up, and it's very instrumental in the transformation of our ego from the fallen state to the risen state because of that opening in the brain. So it's, you know, I never have headaches either. And I've had not just this. I don't know what it is. I can't say it's a real headache, but it's exactly what I'm talking about.

Melainah: Thanks for sharing and I will tell you that the beings of Light and Luminous ones, you know they are learning more and more about our learning to have a better understanding of what it is to be in a body. And part of that is because of our communication with them over these last few months. And so, they're learning you and your body so that they're very attuned to what's going on. They are very attuned to all the noise and the chaos going on the planet. That also is affecting our nervous systems, whether we engage with that or not, just because we are still part of mass consciousness.

So, they are aware of that. And you know, they are monitoring us. And again, you're not being monitored only when you're inside the Luminator. You know, this is an ongoing process. It goes on 24 seven. And it's going to continue for as long as I can't tell you how long because they haven't told me. But just you know, just know there is a lot and just but they're working with that and they are adjusting our frequencies. And if you're noticing that it's a little much or you're having a series of headaches, you know, ask for a little help with that. That's what they're there for. Communicate with them. You know, your Luminous one is there for you.
Anyone? All right. If not, we're going to move on to our next discussion.

The Infusion Sequences

And that is about the infusions. Here in your comments - let's begin with how they were intended to go. And so, we can all be on the same page as we move forward. How about that?

In **December**, in sequence **one**, the Luminator identified and lit up a certain segment of crystalline particles and structures, right? And then those were infused. Okay.

January in sequence **two**, the Luminator identified and lit up **another segment** of crystalline particles and structures. Those were **infused for the first time**. And then **those that you infused in December**, those lit up and those were infused for the **second time**. Okay, so now that brings us to February.

And in **February**, the Luminator identified a **third set of new** groupings of particles and structures. And those were **infused for the first time**.

And then the **sequence that was infused in January** received their **second infusion**. And then those that were infused in the **first sequence in December** received their **third infusion**.

So, to date, if that was followed, the **ones from sequence one have had three infusions.**

The **January** ones have **had two infusions.**

The **February** ones have now had **one infusion.**

So, **three, two, and one** is where they should stand right now.

So, because we have done so well individually and collectively, and we're at a very stable point, the Luminous ones are now going to revise the timeline for these infusions.

So, they have requested that we return to the Luminator sometime over the next few days. And you can, starting as soon as today, for this next infusion.

And so, this one we will **only be infusing those that you just did in February** - in sequence **three** - **only those that have only been infused one time.**

So, you will, over the next few days, those then you will **bring up for their second infusion.** That's all that you are to do.

So, if you have not completed the three, two, one up to this point, do that first - so those are in sequence.

Then go back, or while you're in there, whatever you and - discuss this with your Luminous one and what feels right for your body - then go back in and then do this add-on.

This **add-on** is gonna be considered **part of this third sequence**, okay - is an **extension** to it.

So, once you complete this one, then you'll have **three, two, and two.**

And so do whatever you have to do between now and the time we meet in two weeks, to bring yourself up to that - so everybody's on the same place, and you're ready then for **sequence four, which will come on the 22nd.**

So, before I say anything else, do I need to clarify that? Make that any clearer? Is anybody confused? Does that answer your question? [Well, you could repeat it again - the last part - like the last, the February's infusion.]

Okay, so in February, that was sequence 3. And in sequence 3 the Luminator - it lit up and identified another set of crystalline lights structures and particles okay.

And so that should be infused, and if you haven't done it, then you know you will need to go ahead and get that complete. And that will be the first infusions, sequence three - the February sequence three is the first infusion of the February group, okay.

So now we're asked to return and do those - that very same group for, and allow it to be infused for its second time. So, if you have not brought the first sequence up to three infusions, the second sequence in January up to two, or you have not yet completed the third sequence, you need to do that first, and then go back in and do the second infusion of that third group that was lit up for the first time in February.

[Comment on our Luminous one knowing what to do].

Melainah: They will know, but you need to know. Well, I'll finish. I just want to be sure we're clear here before we get or move on. Did you understand? So, is that clear for you? [I think so.] Okay, I'm happy to say it again if it need be, okay? [The one we do this week is going to add on to the February infusion, correct?

Melainah: Yes. You don't do anything with the one, the December or the January one for this one, okay?

This is just going to bring us all up to equal. So, first thing we will need to do is communicate with your Luminous one when you are ready to go back into the Luminator okay. You will follow the same protocols as you've been doing, which is beginning with - in those four Crystalline chambers okay? And again, you'll only be working with this additional one for that third infusion, unless you are not up to date. Do those first, and then you will do this. Okay?

Joan: I think it's with your intention. That's your intention. And your Luminous one will lead you wherever you need to go. But be specific in your intention.

Melainah: Yes, but they definitely know where you are. But it helps to be on the same page.

Joan: But you need to know.

Melainah: Exactly. Clear communication. All right. If everybody's good with that, all right. And we need to do this so we are prepared again for the March 22nd, because we're going to begin with sequence four, and we all need to be on the same page before we come together on the 22nd, all right?

Joan: And that'll be the only thing that is done that session. The whole session will be devoted to that.

Melainah: Well yes, it'll be devoted to the initiations, right?

Joan: Yeah, right.

Melainah: And on that day, on the 22nd, be sure that you are prepared. You have prepared yourself to enter our Light Temple, which is where we will meet, and that you're prepared for what is to come in those initiations. Okay. If nobody has any other questions about that, I will continue.

[Question about December and 3.] Okay, December - that was the first one, the sequence one. And January, sequence one received its second infusion. [Oh, okay. I thought there was three in December. And then two in January. Oh, that's where I was getting confused. So, three of them is up through February.] Yes. Sequence one received.

Melainah: Three, two, one. [So, we need to do - the second is the 3-2-2, but the last two, we will need to do it on our own. This is not part of what we're doing today?] No, no, no. To bring yourself, you know - have you done the 3-2-1? [Yes.]

So, starting anytime from today over the next few days, go back into the Luminator with your Luminous one. And then what you those that you just brought online in February for the first time, infuse those for the second time. You will do that on your own.

And then that brings us - everybody then should be up - once they do this to 3-2-2, and that's where we will begin on the 22nd. From there. Okay. Anybody else? Okay.

If not, we're going to shift gears here a bit.

So, everybody just take a breath.

And just center.

So, this is 2026. And have any of you realized or thought about that we began ten years ago in 2016, with the Crystal conference. It's our 10-year anniversary.

Joan: Metatron said, oh you need to have a Crystal conference. Oh, we can do that - we have lots of crystals - not even a glimpse of what was to come.

Melainah: Yes, and so here we are ten years later, and we're still talking about crystals. But now we are talking about the crystalline structures of our physical body. How far we have come, okay?
